I further agree that should any claim be made against the Oil Region Alliance in contravention of this Agreement, including but not limited to derivative claims, I will protect, defend and completely indemnify (reimburse) the Oil Region Alliance for any such claim and expenses including attorney's fees and costs incurred by the Oil Region Alliance in defending themselves or security indemnity hereunder.

I understand that the Oil Region Alliance is not responsible for any lost, stolen, or damaged valuables or property. I also release any photos that may involve myself.

I have read the Agreement and understand that by signing the Agreement I have consented to be bound by its terms, including the waiver/release of any legal right I may have to sue the Oil Region Alliance for any costs they incur because a claim or legal action is brought in violation of this Agreement. I agree any violation of the Agreement and its terms and conditions, as determined by the Oil Region Alliance, will void and terminate this Agreement and may result in loss of the ability to use the facility or participate in future events.
